2021 TIMBER VALUE EXTRACTIONS

Chief Appraiser Stokes presented the 2021 Timber Value Extractions for the Board's consideration. There are 4 timber sales in Paulding County for 2020. Additional PT-283T sales reports were received from Polk County, with 31 sales, for a combined 35 total number of sales. Based on the 2020 sales used in this study it is determined that the timber extraction price is \$150 for T1, \$465 for T2, \$775 for T3 and \$1,300 for T4.
