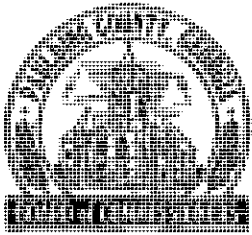
To Whom It May Concern:

The Paulding County Board of Commissioners enacted an ordinance to regulate the vehicle for hire or taxicab industry operating in Paulding County. The ordinance applies to all companies transporting or picking up passengers for hire in Paulding, whether they, the taxicab company, is based in Paulding or another Georgia county. This was done to ensure the safety of their constituents. On August 1, 2007 the ordinance became effective and will be enforced starting September 15, 2007. Below is an abbreviated list of the subsections of the ordinance. Please visit our website at www.paulding.gov to review the ordinance in its entirety. Violations of any part of the ordinance may result in the issuance of a citation, custodial arrest, and revocation of any permits and/or impoundment of any involved vehicles.

- Vehicles Must Be Mechanically Safe & Inspected
- Business Name Must Be Permanently Displayed On Exterior of Front Doors
- Taxi Must Be Equipped With Calibrated & Certified Taximeter
- Taxi Must Be Equipped With Top Light, Spare Tire and Jack, Partition and a Fire Extinguisher
- Schedule Of Rates Must Be Posted On Exterior Of Vehicle
- Paulding and Atlanta Map Required
- Receipt Book & Log Sheet Required
- Cruising & Call Jumping Prohibited
- Age of Vehicle Must Be No More Than 10 Years Old (1997 or Newer)

- Has provided a copy of the companies fare rate schedule and daily hours of operation
- Has provided a name, address and telephone number of a registered agent residing in Paulding County
- Has provided proof of insurance as required by Section 70-78

OUT OF COUNTY REQUIREMENTS

These requirements must be met and approval must be received from the Chief Marshal or his designee before Paulding County Community Development may issue a Business Permit.

- Has successfully passed a criminal background check as outlined in Section 70-77 (b) of the ordinance.
- Owns or leases no less than eight (8) appropriately marked taxicabs
- Has provided proof of a valid and current occupation tax certificate to do business issued by a city, county or consolidated government in GA.
- Applicant Owner, Partners, Officers and/or Managers are all at least 21 years of age
- Is a U.S. citizen or legal alien admitted for permanent residence or who has otherwise been granted employment authorization by I.C.E.
- Has successfully passed a criminal background check as outlined in Section 70-77 (g)(3) of the ordinance.
- Has a verified dispatch location outside Paulding County, staffed by business agents or employees and has a published telephone number
- Has filed for the initial permitting and inspection of all taxicabs and has supplied a list of drivers and proof of insurance for contract drivers.
- Has provided a copy of the companies fare rate schedule and daily hours of operation
- Has provided a name, address and telephone number of a registered agent residing in Paulding County

Chapter 70 of the Paulding County Code of Ordinance Section 70-77, paragraph (6), subparagraph (f) requires the business applicant to provide a copy of the applicant's rate schedule and daily hours of operation to the Marshal Bureau.

Further, Chapter 70, Section 70-90, directs that the fares that the company and/or driver charges to the public shall be prominently displayed on the rear door or rear quarter panel of each side of every taxicab. Each letter used in the display shall be no smaller than one (1) inch height and half (1/2) an inch wide.

The advertised fare shall include the price for the first seventh of a mile, each additional seventh of a mile, waiting time (per hour) and any fee charged for each additional passenger.

Additionally, the schedule of fares being utilized must be posted in the taxicab at all times and must be legible.

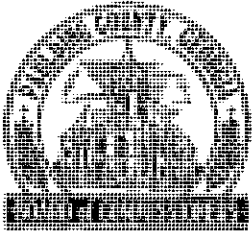

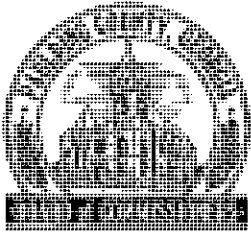
