**Note:** If an objection is timely filed, this Court will either set a hearing at a time certain before the Probate Judge, or the records relating to the temporary guardianship will be transferred to the Juvenile Court of Paulding County, which shall determine, after notice and hearing, whether a continuation or dissolution of the temporary guardianship is in the best interest of the minor.

If no objection is timely filed, the Court will remove you as temporary guardian(s) and dissolve the temporary guardianship without a further hearing.
