Update: Nebo Road Drive-By Shooting/Chase Related to Atlanta Shooting

(Paulding County, GA) The Paulding County Sheriff's Office would like to offer some clarity on the press release that was disseminated earlier today regarding the drive-by shooting and vehicle pursuit that took place on Monday June 28, 2021 in the area of Nebo Road. Listed below is the chronological order of what took place and when. It must be noted that yesterday's Paulding County incident has direct ties to the Peninsula Apartment shooting that took place on May 15, 2021 in Atlanta.

-May 15, 2021 a shooting occurred in Atlanta at the Peninsula Apartments 2591 Piedmont Road NE Atlanta. (This was confirmed by an Atlanta Police Press Release).

-June 25, 2021 at approximately 12:05 AM a drive-by shooting occurred at 7675 Nebo Road Hiram, GA 30141 (Paulding County Sheriff's Office).

-June 28, 2021 Cobb Police Officers surveil the residence at 7675 Nebo Road Hiram, GA 30141 regarding a shooting investigation. The shooting they were investigating occurred in Cobb County.

-June 28, 2021 at approximately 2:00 PM Cobb Officers give a lookout to Paulding Deputies on a red Honda Civic that left 7675 Nebo Road Hiram, GA 30141.

-June 28 2021 at approximately 2:15 PM Paulding Deputies locate the red Honda Civic on Nebo Road in the area of South Paulding Middle School and a chase ensues.

-June 28, 2021 at approximately 2:20 PM the red Honda Civic crashes and the male driver, identified as Christopher Eli Koen (B/M, 20 YOA) flees on foot. Koen would

be captured at approximately 5:13 PM on June 28, 2021. (See first press release for more details).

-June 28, 2021 at approximately 3:00 PM Cobb Police Officers and Paulding Deputies surround the home located at 7675 Nebo Road Hiram, GA 30141. Deputies and Officers arrest James Daniels, Nicholas Poole, and Bryce Dowell at 7675 Nebo Road Hiram, GA 30141 on warrants out of Cobb County and Atlanta PD (see below for more details).

-June 28, 2021 later in the day, Cobb Police secure a search warrant for 7675 Nebo Road Hiram, GA 30141 and discover multiple stolen firearms which resulted in more charges for Daniels, Poole, and Dowell in Paulding County.

June 29, 2021 Atlanta Police confirm that James Daniels, Nicholas Poole, and Bryce Dowell, who were arrested at 7675 Nebo Road Hiram, GA 30141 on June 28, 2021 in Paulding County, were the same individuals that were involved in the Peninsula Apartments shooting in Atlanta (This was confirmed by an Atlanta Police press release).
