STANDING ORDER FOR COLLECTION OF FEES FOR COUNTY LAW LIBRARY

Pursuant to the authority granted by O.C.G.A. § 36-15-9(a), the Clerks of all courts of record in the Paulding Judicial Circuit, to include Superior Court, Probate Court and Juvenile Court, as well as the Magistrate Court, are hereby authorized to collect the sum of five dollars (\$5.00) as an additional fee, effective September 1, 2019, in the filing of all civil, criminal, or quasi-criminal matters and proceedings filed in their court. The fees collected pursuant to this Order shall be remitted by the Clerk to the Treasurer of the Board of Trustees of the County Law Library of Paulding County on the first (1st) day of each month.


When the costs in criminal cases are not collected, the costs provided in this Order shall be paid from the fines and forfeitures fund of the court in which the case is filed, before any other disbursements or distribution of such fines or forfeitures is made.

IT IS FURTHER ORDERED, that the Clerk of each court shall spread this Order upon the minutes of the court in which they serve.


