<u>Detention Officer Caleb Lindsey Awarded the</u> <u>Commissioner's Public Safety Award</u>

(Paulding County, GA) On May 27, 2014 Detention Officer Caleb Lindsey of the Paulding County Sheriff's Office Detention Center was awarded the Paulding County Board of Commissioner's Public Safety Award. Detention Officer Lindsey was awarded the Commissioner's Public Safety Award for his exemplary service to the Detention Center as well as the Paulding County Sheriff's Office. In addition to his exemplary service, Detention Officer Lindsey saved the life of an unconscious and non-responsive inmate by performing CPR. By performing CPR, Detention Officer Lindsey got the inmate breathing again and kept him stable until EMS personnel could arrive. The inmate was later transported to the hospital where he recovered from his condition. Detention Officer Lindsey has been employed as a Detention Officer in the Paulding County Sheriff's Office Detention Center for nearly a year.

Detention Officer Lindsey was presented with a Certificate of Appreciation from the Board of Commissioners along with a "Dinner for Two" Gift Card from *Texas Roadhouse*.
